MUNICIPAL ORDINANCE NO. 6
Series of 2018

AN ORDINANCE CREATING A PUBLIC NUISANCE ADMINISTRATIVE BOARD OF THE MUNICIPALITY OF BUENAVISTA, BOHOL.

Sponsored by Hon. Artemio C. Lopez

Be it ordained by the Sangguniang Bayan of the Municipality of Buenavista in session assembled that:

Section 1. Definition of Terms.

The following term as defined herein, for purposes of this ordinance shall mean:

1. Public Nuisance – pursuant to section 52 of RA 9165 it refers to any place or premises which have been used on two or more occasions as the site of the unlawful use, sale or delivery of dangerous drugs;

Section 2. Public Nuisance Administrative Board.

The Public Nuisance Administrative Board (PNB) is hereby created which shall operate under the office of the Mayor for the purpose of abating drug-related public nuisance.

Section 3. Functions.

The PNAB shall perform the following functions:

1. Ensure full compliance, participation and support to the provisions of RA 9165;
2. Develop comprehensive, integrated, unified and balanced prevention and strategy in controlling the proliferation of drug-related nuisances;

3. Address the drug problems related to prevention, anti-drug education programs and the rehabilitation or treatment of drug dependents;
4. Ensure that the Municipal Anti-Drug Abuse Council of Buenavista and the Barangay Drug-Abuse Councils (BADACS) in the barangay levels are actively and effectively functional;
5. Formulate sustainable Anti-Drug Abuse program in matters relating to rehabilitation or treatment process of drug dependents;
6. Coordinate with the Dangerous Drug Board;

Section 4. Powers.

The PNAB, in order to accomplish its function shall have the power authority as follows:

1. Act as quasi-judicial body empowered to hear drug-related complaints on public nuisance;
2. Formulate rules and procedures in the disposition of complaints against drug-related public nuisance;
3. Declare any place or premises which has been used in the unlawful sale or delivery of dangerous drug as public nuisance;
4. Issue or lift orders prohibiting the conduct, operation or maintenance of any business or activity in an area certain premises that is deemed as public nuisance;

Section 5. Composition:

Chair : Mayor

Vice-Mayor : Chair, Committee on Public Order and Safety

Regular Members : SP Committee Chair on Youth Development

Municipal Health Officer

Socio-civic / Religious Leader

Chief, PNP – Buenavista

Liga ng mga Barangay President

Section 6. Meeting.

The Board shall meet regularly at least once a month or necessary at the call of the chair or of simple majority of the members;

Section 7. Appropriation.

The operation of the board shall be funded from a slice of the appropriation for Gender and Development;

Section 8. Effectivity.

This ordinance shall take effect immediately upon its approval by the SangguniangPanlalawigan.
